Efforts to implement a participatory evaluation plan for Comprehensive Partnerships to Advance Cancer Health Equity

- The collaborative development of CPACHE performance standards will help each partnership conduct more relevant and effective cancer research, training, outreach, and education aimed at advancing cancer health equity.
- Although each partnership can collect additional information based on their needs, focus and structure, the evaluation matrix reflects a collaborative evaluation plan. Significant engagement, participation, and commitment from all stakeholders is critical for success.
